## OFFICIAL HALLOWEEN COSTUME CONTEST RULES

NO PURCHASE NECESSARY, A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

MUST BE PRESENT TO WIN AND CLAIM A PRIZE.

This promotion is sponsored by Gresham Station (the "Center") and HIP Gresham Station, LLC ("Sponsor").

**ELIGIBILITY**: The Gresham Station Halloween Costume Contest (the "Contest") is open to individuals of all ages, however, in order to be eligible for a prize, only those participants registered in advance on the day of the Contest and who are 18 years or older are eligible. No employee of the Sponsor, anyone related to an employee of the Sponsor, or any employee of any tenant at the Center are eligible for a prize. One entry per household. A household is determined as any individuals residing at the same address or under the supervision of the same adult, guardian or caregiver.

**AGREEMENT TO BE BOUND BY OFFICIAL RULES**: Participation in the Contest constitutes full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor and the judges, which are final and binding. Sponsor reserves the right to cancel, suspend and/or modify the Contest.

**TO ENTER**: The Contest will be on <u>October 27, 2019 at 1:00 pm</u> at the Center. Prior to the start of the Contest, between 12:00 pm and 1:00 pm all participants must complete and return to the Sponsor a registration form to participate and to be eligible for a prize. Maximum of one (1) entry per person or group and registration for the Contest is limited to the first 100 individuals to complete registration cards.

**JUDGING**: The Contest will be judged by a panel of local leaders and businesspeople. The decision of the Judges will be final and binding. Costumes will be judged on creativity, originality and detail.

PRIZES: First Prize: Trip to Disneyland for a family of 4 (Trip to be arranged through "Bucket List Travel Tours". Some restrictions apply.) Winners of the First Prize must be at least 18 years of age; 2nd Prize: \$1000.00 to spend at the Center (Winner's choice of no more than 10 Gift Cards to spend at the Center with minimum purchase of \$100 at each retailer); 3rd Prize: \$500.00 to spend at the Center (Winner's choice of no more than 5 Gift Cards to spend at the Center with minimum purchase of \$100 at each retailer). Prizes are non-transferable, no substitutions will be made, and are not redeemable for cash. All local, state and federal taxes and fees associated with any prize are the sole responsibility of each winner. The odds of winning a prize depend on the number of eligible entries received. **LIMITATIONS OF LIABILITY**: Sponsor and its affiliates (the "Released Parties") are not responsible for: (a) any inaccurate information, whether caused by entrants or printing errors; (b) unauthorized human intervention in any part of the Contest; (c) technical or human error which may occur in the administration of the Contest or the processing of entries; or (d) any injury or damage to persons or property including, but not limited to, death, which may be caused, directly or indirectly, in whole or in part, from participation in the Contest or receipt of any prize. Sponsor shall not be responsible for cancellations or delays of airline or hotel accommodations.
